Terms & Conditions

We would like to think our Terms and Conditions are written in a clear and friendly manner and try to avoid technical and legal jargon. They are provided to ensure we all understand each other's requirements & expectations and you get the service you expect from us. If you have any questions please speak to us and we shall endeavor to clarify the T&Cs.

General

The following Terms and Conditions listed below relates to all photographic work performed by Advanced Image Photography and its associates, and signing the Wedding Booking Form assumes you fully agree with these Terms & Conditions.

Terminology

"The Client" – The Wedding Couple or either of the Wedding Couple

"The Photographer" – Any photographer or assistant working for Advanced Image Photography during the period of your wedding day.

"AIP", "we" – Advanced Image Photography

"The Contract" – The agreement between *the Client* and *AIP* instigated by signing the Wedding Booking form.

Payment

We request a non-refundable deposit of £150 to reserve your wedding date as stated on the Wedding Booking Form. The full balance of the payment is required at least 28 days prior to the wedding. Payments can be made by Credit & Debit Cards, PayPal and Direct Transfer.

Cancellation / Change of Date / Change of Venue

The Client can cancel the booking without incurring any penalties, other than the non-refundable deposit, at any time up until the balance is paid. Cancellation should be made in writing (email acceptable) by *the Client*. Cancellations made within 28 days of the wedding will result in the loss of all monies paid unless a new booking date is mutually accepted.

If, for any serious unforeseen circumstances, on behalf of *AIP*, we are not able to fulfill our responsibilities we shall not be liable for any amount in excess of that already paid by *the Client*.

Changes to the venue, date, time or other important details must be submitted in writing at least 14 days before the agreed date to *AIP*. *AIP* will take all reasonable measures to accommodate these changes. Should the new date, venue etc not be available for *AIP*, and no alternate *Photographer(s)* can be allocated, *the Client* will deem to have cancelled *the contract*.

Attendance

If, due to unforeseen circumstances, the designated *photographer(s)* is unable to attend your wedding, we reserve the right to appoint another *photographer(s)* to perform the wedding photography to the best of their ability.

Copyright & Display

AIP will retain the copyright of all photographs taken during the *Client's* wedding day and may choose to display any of these photographs on its Website, at Exhibitions, in Sample Albums etc.

Royalty Free License

As described above, *AIP* retain ownership of all photographs, but all *AIP* Wedding Packages provide a Royalty Free License which allows *the Client* to use the photographs freely for non-commercial use without further payment.

Best Endeavors

The *photographer(s)* will use their experience, skills and best endeavor to capture all photographs as requested by *the Client*. Should guests be uncooperative or unavailable to have their photographs taken it becomes the *Client's* responsibility to resolve the situation. Where restrictions at the venue or weather conditions prevent certain photographs to be captured, the *photographer(s)* will use best endeavor to provide alternative photographs but will not be held responsible for the lack of specific photographs resulting from circumstances beyond their control.
